AKRA Announces Dividend of Rp 80 per Share for the Year 2014 Final Dividend of Rp 30 per Share Payable on May 29, 2015

JAKARTA – The Annual General Meeting of Shareholders of PT AKR Corporindo Tbk (the "Company") for the year 2014, approved dividend payout of Rp 80 per share amounting to Rp 313.363.452.220. This represents a payout of 38.7% of the audited net profit for the year ended 31 December 2014 of Rp 810.094.166.000.
